**Proposal:** A Conditional Use Permit for the replacement of Baker Middle School and the construction of associated off-street parking facilities and sports fields. The new school and associated facilities are proposed to be located at the northerly end of the site, in the general vicinity of Harmon Park. The subject site is located within the "R-2" Single-Family Dwelling District. The *Tacoma Municipal Code* requires a Conditional Use Permit for educational uses within the "R-2" District.
